



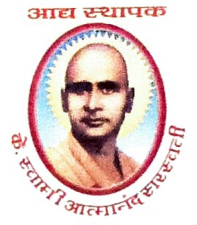

5. Joint guidance of student projects.





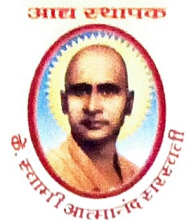

On its part, the institute shall consider and try to the extent possible.

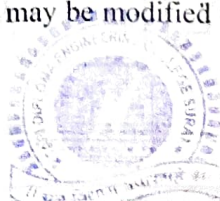
1. To offer the library/infrastructure/other amenities/facility of the institute to the company/organization personnel if required by the company/organization as per a procedure which is mutually evolved.
